



AGREEMENT TO ESTABLISH A DOUBLE DEGREE PROGRAMME

Between

Sapienza Università di Roma - Faculty of Political Sciences, Sociology and Communication

And

Sciences Po Lille (Institut d'Etudes Politiques de Lille)

Article 1 - Preamble

Sapienza University of Rome, represented by the Rectress Prof. Antonella Polimeni, Città Universitaria, Piazzale Aldo Moro 5, 00185 Rome,

And

Sciences Po Lille represented by the Director Prof. Pierre Mathiot, 09 rue Angellier 59 000 Lille.

- Considering the efforts to harmonise higher education and to establish international curricula that foster an international labour market as well as improve student mobility,
- Considering the demonstrated interest by Sciences Po Lille to promote and initiate an international curriculum with the Department of Political Sciences, of "Sapienza" University of Rome;
- Having regard to the DM 270/2004 (revision of the act 509/1999) of the Minister for Education, University, and Research, that allows Italian universities to independently develop their own curricula (according to the law 341 of the 19-11-1990, art.11);
- Having regards to the Executive Decree n°91-582 (13th of June 1991) and to the
 Executive Decree n°2016-1114 (11th of August 2016) establishing the association
 between Sciences Po Lille (Institut d'Etudes Politiques de Lille) and the University Lille 2
 and that allows Sciences Po Lille to independently develop its own curricula (according
 to the Education Code)
- Having regards to the pre-existing Erasmus + Inter-institutional1 agreement (Key Action
 1 Mobility for learners and staff Higher Education Student and Staff Mobility)
- Having regards to the respective internationalization strategies of Sapienza University of Rome and Sciences Po Lille.

The Department of Political Science of Sapienza University of Rome - hereafter named "Sapienza"

and

Sciences Po Lille - hereafter named "SPL"

both approve the text of this agreement aiming at the establishment of a double degree Programme, and undertake to award the following diplomas:

Laurea Triennale in Political Sciences and International Relations (L-36) and Administration and Organisation Sciences (L-16) delivered by Sapienza, Department of Political Sciences

Laurea Magistrale in International Relations (LM-52) and Political Sciences (LM-62) and Sciences of Administration and Public Policies (LM-63) delivered by Sapienza, Department of Political Sciences.

Certificat d'Etudes Politiques (CEP) delivered by Sciences Po Lille

Diploma of Science Po Lille (Master's Degree) in Political Sciences and International Sciences delivered by Sciences Po Lille

Article 2 - Programme management

2.1 The two partner institutions will appoint a Programme coordinator each.

2.2 Each partner agrees:

- to participate in a cooperative manner in the meetings of the different bodies under this Agreement:
- to promptly notify any delay in performance or any event that may impact the Programme to the appropriate body;

- to inform the appropriate body of relevant communications it receives from third parties in relation to the Programme;

to ensure the accuracy of any information it supplies to the other Partners and to promptly correct any error therein of which it is notified, whereas the recipient Partners shall be responsible for the use made of such information;

to act at all times in good faith and in a manner that reflects the good name, goodwill and

reputation of the other Partners and in accordance with good business ethics.

2.3 Each University will be responsible for its own costs associated with this Inter-Institutional Agreement. Neither University will have the authority to authorize or incur financial liability on behalf of the other.

2.4 Due consideration should be given to the opportunities offered by the Erasmus+ Programme, or other international Programmes in order to fund scholarships for student and staff mobility.

Article 3 - Teaching Programme

- 3.1 The curriculum of this Double Degree Programme is presented in Annex 1 which is an integral part of this agreement. Changes to the annex do not affect the whole agreement.
- 3.2 The two institutions share the organization and the management of this Programme which can be updated with both institutions' mutual agreement.

Article 4 - Admission requirements and procedures

- 4.1 The signing institutions will ensure provision of the required number of places. The number of students that will participate in the Double Degree Programme will be jointly determined by both institutions on a yearly basis in the period between February and May. For the first year of the Programme the parties agree to set the maximum number of students to 15 for each of the participating institution.
- 4.2 Student admission is separately conducted by each institution. The Programme coordinator of each Institution is responsible for student advising and student selection based on the following minimum requirements:
 - The students in SPL will be selected through a competitive exam prior to the start of the 1st year. This section will test general knowledge of political sciences, history and Italian language.

 The students in Sapienza will be selected on a competitive call based on comparative call and interview during the first year of their enrolment at Sapienza. Sapienza students studying at SPL in the framework of an Erasmus + exchange could also apply to incorporate the double degree programme.

Students selected by Sapienza have 3 options:

 Being enrolled in the Double Degree for both cycles (Laurea + Laurea Magistrale, 5 years)

o Being enrolled in the Double Degree during the first cycle (Laurea, 3 years)

- Being enrolled in the Double Degree during the second cycle (Laurea Magistrale, 2 years). (This option might be allowed only starting from the 3° year of the implementation of this Agreement).
- Students have to demonstrate their language proficiency in French and Italian (level B2 or equivalent): Languages will be evaluated during the selection process.
- 4.3. The Programme coordinator of each university will inform the partner institution about the selected students immediately after the selection process has been completed.
- 4.4. In order to be enrolled at SPL, students have to submit the following documents: a nomination and selection letter from Sapienza.

Article 5 - Student mobility

- 5.1 All the students enrolled in this Double Degree from both institutions will attend 2 years of study at the partner institution according to the details explained below. Courses at partner university will be taught in Italian, French and English.
 - 1. For the students selected by Sapienza:

1.1: The first year takes place at Sapienza, at the Facoltà di Scienze Politiche, Sociologia e Comunicazione del Dipartimento di Scienze Politiche.

1.2: The second year takes place at SPL in the framework of the Political Studies Certificate (programme Eramsus+ as well as any other scholarship made available by Sapienza). Students selected by Sapienza will get at SPL the CEP (certificat d'études politiques).

1.3: The third year takes place at Sapienza, at the Facoltà di Scienze Politiche, Sociologia e Comunicazione del Dipartimento di Scienze Politiche (180 ETCS).

- 1.4: The fourth year takes place at SPL in the framewok of the Master programme. (Programme Eramsus+ as well as any other scholarship made available by Sapienza).
- 1.5: The fifth year takes place at Sapienza in the framework of one of the Laurea specialistica relevant with the Master's programme attended during the fourth year (300 ETCS).
- 2. For the students selected by SPL

2.1: The first year takes place at SPL in the framework of the first cycle.

- 2.2: The second year takes place at Sapienza, at the Facoltà di Scienze Politiche, Sociologia e Comunicazione del Dipartimento di Scienze Politiche, in the framework of the Erasmus + programme. Students will integrate courses in L-36 or L-16
- 2.3: The third year takes place at SPL in the framework of the first cycle (180 FCTS)
- 2.4: The fourth year takes place at Sapienza in the framework of one of the Laurea specialistica. Students will integrate courses in LM-52, LM-62 or LM-63

- 2.5: The fifth year takes place at SPL in the framework of one of Masters' programme relevant with the Laurea specialistica attended during the fourth year (300 ETCS). (300 ECTS).
- 5.2 Students from Sapienza will take 120 ECTS at SPL University. The students from SPL University will take 120 ECTS at Sapienza.

Student will present a final thesis at their home university.

5.4 Students who failed one or more exams at SPL are required to reset the respective exams, yet only once. Re-Examinations will be provided and graded by SPL but may be retaken at Sapienza after the students' arrival in Rome.

Article 6 - Tuition fees

6.1 Registration and tuition fees will be paid to the home institution and be exempted by the host institution, which will guarantee a fee waiver upon condition of reciprocity.

Article 7 - Degree

- 7.1 Upon successful completion of the Double Degree requirements (300 ECTS), three separate diplomas are conferred to the student according to the local regulations:
 - The degree from the SPL: Diploma of Science Po Lille (Master's degree) together with diploma supplement, if available.
 - The degree from the Sapienza University of Rome: Laurea Triennale in Political Sciences and International Relations (L-36) and Administration and Organisation Sciences (L-16)
 - The degree from the Sapienza University of Rome: Laurea Magistrale in Political Sciences (LM-62), and International Relations (LM-52) and Sciences of Administration and Public Policies (LM-63) delivered by Sapienza, Department of Political Sciences together with diploma supplement, if available.
- 7.2 The first and the last degrees mentioned in 7.1 are recognized in Europe as master's degrees allowing the student to start a Ph. D. Programme.

Article 8 - Student enrolment, credit recognition and transfer

- 8.1 Each partner will keep appropriate records of the students registered on the Programme and provide all students and partners with the official transcript of records.
- 8.2 Transferring credits between the partner institutions will be made using The European Credit Transfer System (ECTS) as described in annexes, Tables 3 & 4
- 8.3 Courses transferred between the institutions must have minimum grade of Pass or equivalent (see annex, Tables 3 and 4).
- 8.4 Courses will be transferred to the partner institution as soon as the grades in the partner institution are posted.

Article 9 - Thesis, evaluation, composition jury and transfer of documents

- 9.1 The final thesis at the end of each cycle must be presented at the home university. The final thesis at the end of the second year of the Master's cycle must be presented at the home university. Sapienza will appoint a jury according to current regulations and the partner will appoint one assessor. This international jury will jointly assess the degree thesis.
- 9.2. Students have to write the final thesis in the language of the institution where they are studying their third of fourth year (in Italian if studying at Sapienza; in French if studying in SPL) A copy of the final thesis will be submitted to both institutions.
- 9.3 The Partners agree to mutually recognize the thesis done at a partner university, to accept the results of examination and the grades given.
- 9.4 To complete the double degree, students must follow at every stage of the program the respective internal rules and regulations (exams, final dissertations) of both institutions

Article 10 - Conversion of grades of exams and final dissertation

10.1 The European Credit Transfer System (ECTS) will be used for grading the results of any exam and final grade (see annex 1, Tables 5).

Article 11 - Students' right and duties

- 11.1 Each student will be enrolled at the home institution while they will be registered at the host institution for the mobility period.
- 11.2 Students are granted full access to both the institutions' facilities (such as Library, Laboratories, etc.) during their studies. Health insurance is regulated by the rules of each University. Students will be in charge of their respective insurance fees.

Article 12 - Contact Persons / Programme Coordinators

- 12.1 Each university appoints a Programme coordinator who will be in charge of the administrative execution of this agreement and who will serve as the contact person for the Sapienza and SPL students who are participating in the outlined double degree Programme.
- 12.2 The contact persons / Programme coordinators from SPL are:

Article 13 - Duration and renewal

13.1 The agreement will be effective from the date of the last approval, is valid for 5 years, but may be terminated by either party with six months' written notice. If such termination is made, the Programme will be active until all students already enrolled in this double degree Programme have completed their studies. The parties may also extend this agreement for any mutually agreed period of time.

Article 14 - Final regulations

14.1 In the event of a dispute the parties shall endeavor to reach an amicable settlement. Should these attempts fail, the dispute/s shall be referred for settlement to an agreed upon third party. Made in four (4) original copies, each party receiving two (2) original copies.
